## 3.2 Qualification

**3.2.1** It is understood and agreed that the pre-qualification data on prospective bidders is to be used by the Nursing Council in determining according to its sole judgment and discretion, the qualifications of prospective bidder to perform in respect to the tender lot as described by client.

**3.2.2** Prospective bidders will not be considered qualified unless in the judgment of the Council they possess capability, experience, qualified personnel available and suitability of equipment and net current assets or working capital sufficient to satisfactorily execute the contract for goods/services.

## 3.3 Essential Criteria for Pre-Qualification

### 3.3.1 Experience

- a) Prospective bidders shall have at least 1 year experience in the supply of goods, services and allied items. A potential supplier/contractor should show competence, willingness and capacity to service the contract.
- b) Prospective suppliers require special experience and capability to organize supply and deliver items or services on short notice.

### 3.3.2 Personnel

The names and pertinent information and the CV of the key personnel for individuals or groups to execute the contract must be indicated in form NCK PQ-3

### 3.3.3 Financial Condition

The supplier's financial condition will be determined by the latest financial statement submitted with the prequalification documents from their bankers regarding supplier's credit position. Potential suppliers/contractors will be prequalified on the satisfactory information given.

### 3.3.4 Past performance

Past performance will be given due consideration in pre-qualifying bidders. Letters of reference from past customers should be included in form NCK PQ-5 where applicable.

## 3.4 Statement

Application must include a sworn statement (form PQ-6) by the Tenderer ensuring the accuracy of the information given.

### 3.5 Withdrawal of Pre-Qualifications

Should conditions arise between the time of this pre-qualification to bid and bid opening date, which in the opinion of the client/NCK could substantially change the performance and qualification of the bidder and of his ability to perform such as but not limited to bankruptcy, change in ownership or new commitments, the Council reserves the right to reject the tender from such a bidder even though he was initially pre-qualified.
